6 (collectively, the "Parties"), by and through their respective counsels of record, which refers to a

9 IT IS HEREBY ORDERED that the hearing scheduled for May 24, 2018, at 10:00 a.m., is

11 IT IS HEREBY FURTHER ORDERED that pursuant to LR 9014(d)(2), Defendant CANET's
12 deadline to file and serve his reply to MARGOLIN's Opposition to his Counter-Motion will be 7 days
13 preceding the continued hearing date of June 13, 2018 at 2:00 p.m.

14 IT IS HEREBY FURTHER ORDERED that pursuant to LR 9014(d)(1), Defendant
15 MARGOLIN's deadline to file and serve his Opposition to PLAINTIFF's Motion will be 14 days
16 preceding the current hearing date of June 13, 2018 at 2:00 p.m.

17 IT IS HEREBY FURTHER ORDERED that pursuant to LR 9014(d)(2), PLAINTIFF's deadline
18 to file its reply to Defendant MARGOLIN's Opposition will be 7 days preceding the current hearing date
19 of June 13, 2018 at 2:00 p.m.

20 IT IS HEREBY FURTHER ORDERED that as provided by the Fed. R. Bankr. P. 7062, this
21 Stipulation shall be effective and enforceable immediately upon entry.

22 IT IS HEREBY FURTHER ORDERED that this Court retains jurisdiction to hear all matters
23 related to or arising from the entry of the Stipulation.
